

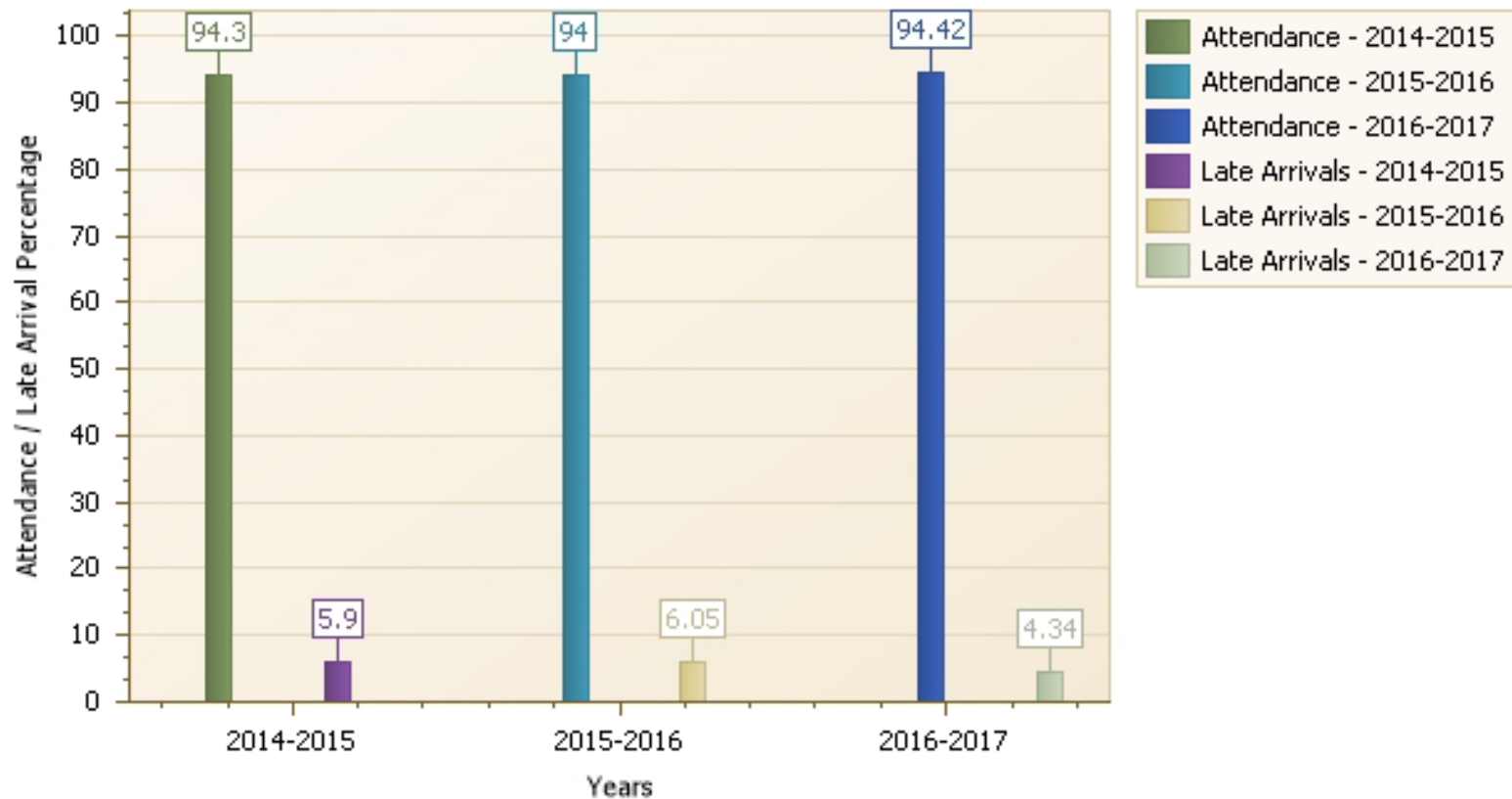

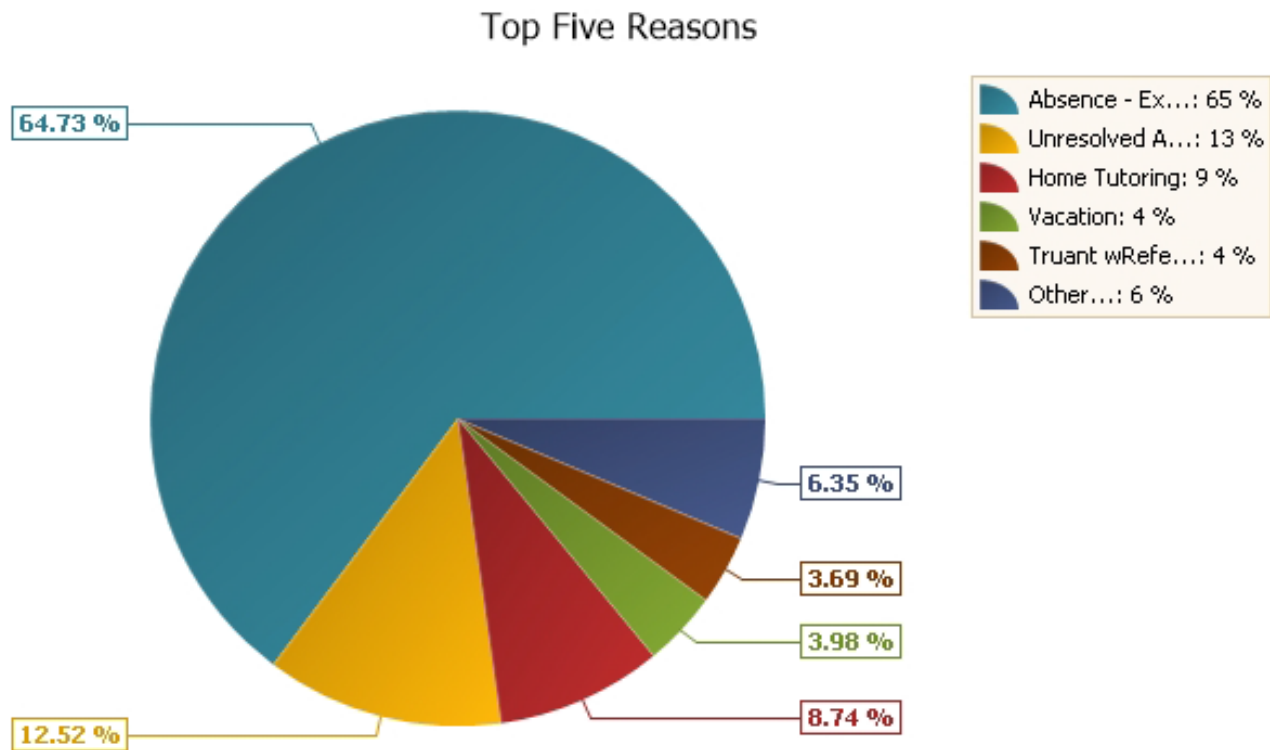

Annual Attendance/Tardy Rates

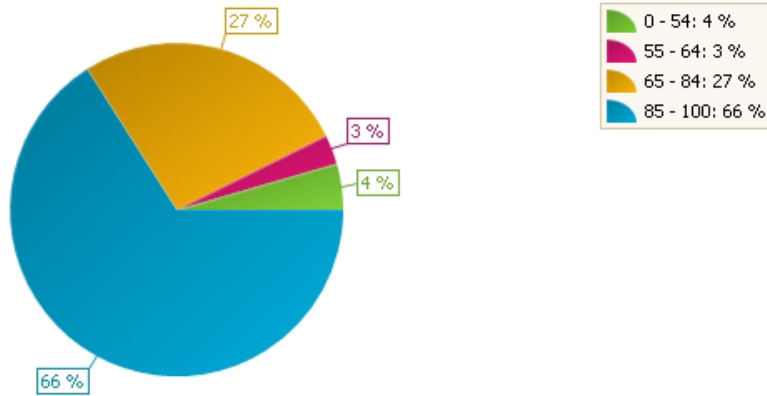
Yearly Attendance and Late Arrival Percentages



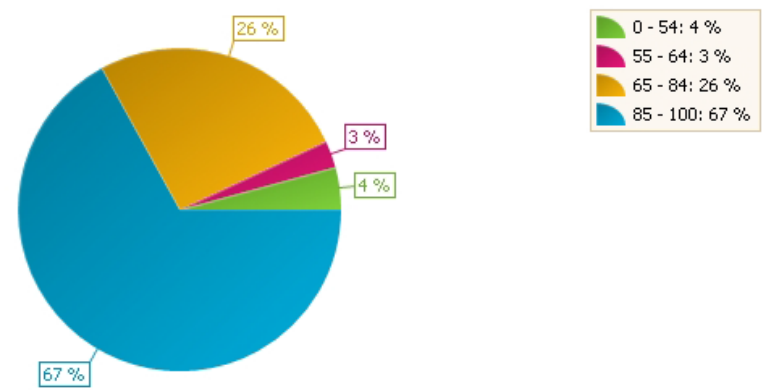
Breakdown of Absences



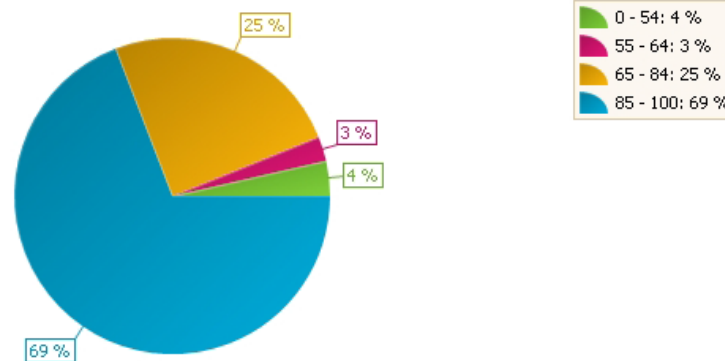
Marking Period One: Performance Summary

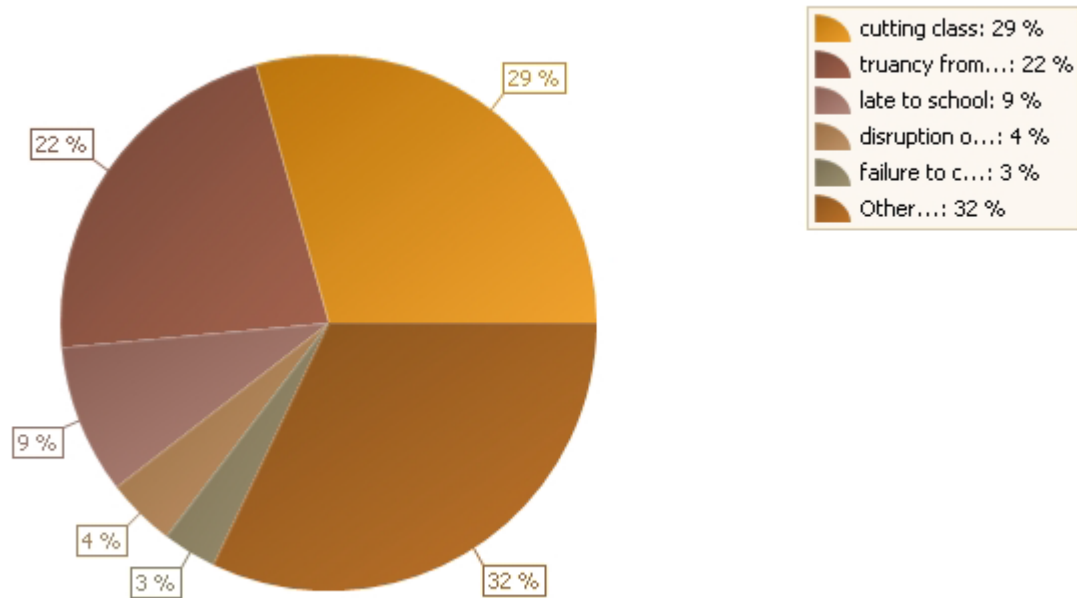

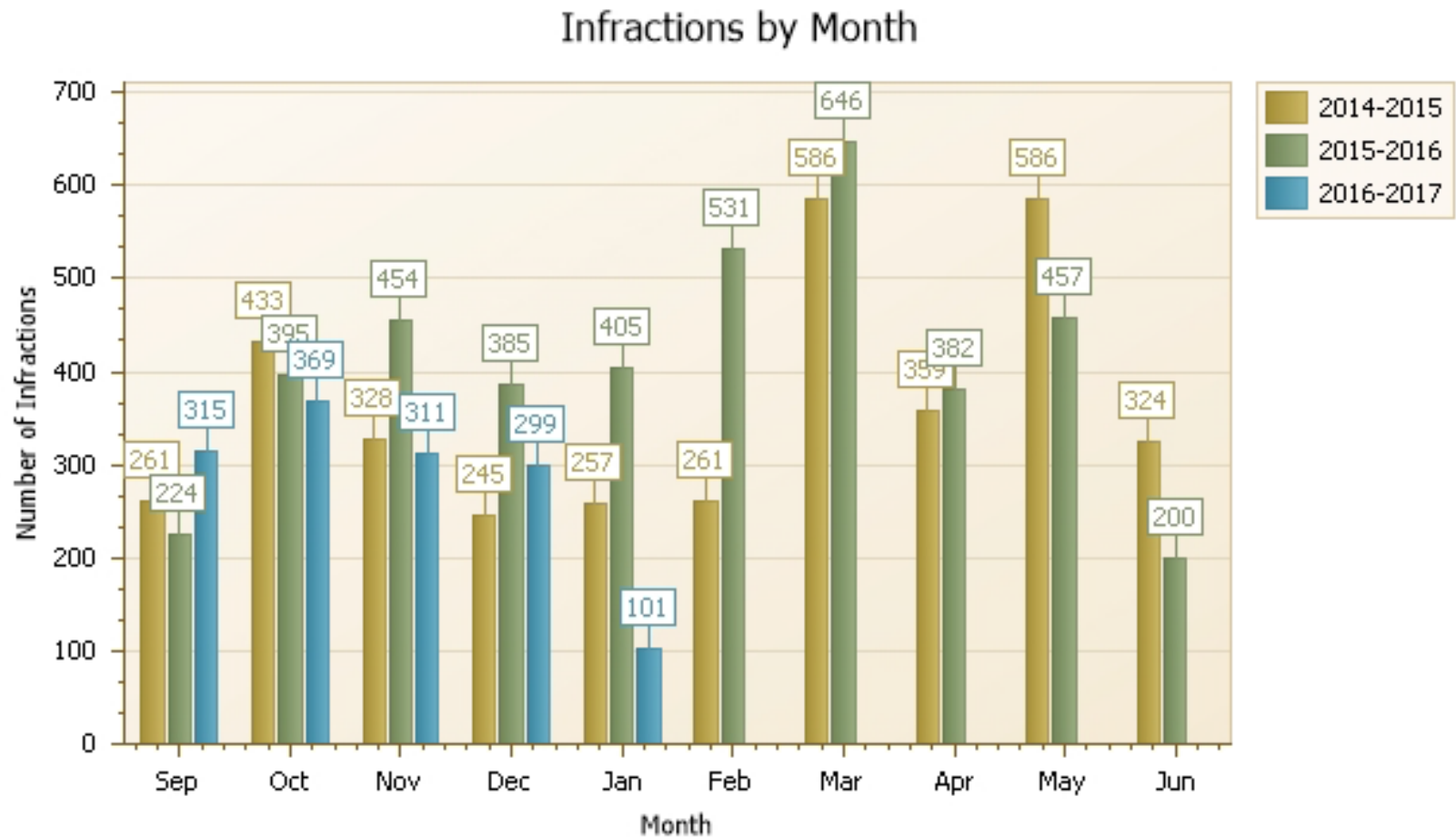
